

2. All Chief Commissioners/ Directors General/ Director (RL), CRCL were, earlier, requested to compile the inputs provided by Commissionerates/ Directorates under their jurisdiction in the prescribed format and furnish the same to the Board. However, it is seen that copies of requisite APARs/ IPRs and other supporting documents, as required by the Board, have not been provided by some CCAs (list enclosed).

3. The meeting of Internal Committee under FR 56(j) and Rule 48(1)(b) of CCS (Pension) Rules, 1972 was held in the Board on 20.12.2016. The following has been decided:-

- (i) to seek details of already reviewed officers, at the time they had attained age of 50/55 years.
- (ii) to review all the Group 'A' officers, who have already attained age of 50/55 years in the past.
- (iii) to schedule the next meeting of Internal Committee in mid-January, 2017 to cover all the cases till quarter April-June, 2017.
- (iv) to schedule another meeting of Internal Committee in mid-February, 2017 to cover all the cases for the quarter July-September, 2017 and streamline the process of holding meeting as per DoPT's instructions.


