2. **Course Objectives:** Network forensics relates to the monitoring and analysis of computer network traffic for the purposes of information gathering, legal evidence or intrusion detection. Network investigations deal with volatile and dynamic information. The captured network traffic can include tasks such as reassembling transferred files, searching for keywords and parsing human communication such as emails or chat sessions.

3. Nominations are requested for the said course. As the course is of technical nature we request the states / CPDs to nominate those officers who are either working in the field of cyber crimes / cyber security or who are supervising such units.

4. It is requested to nominate 3/2/1 IPS/Police Officers of the rank of ASP and above from States/ UTs, IRS officers of equivalent rank from CBDT/ CBEC/ CEIB/ DRI/ FIU-Ind and Enforcement Directorate to attend the Course as per the table below:

6. The Programme is fully residential and the participants of the Course will be staying in the Academy. The expenditure to be incurred on boarding and lodging of the participants shall be met by the Academy. However, the expenditure on account of travel of officers for attending the course to be borne by the respective State / Central Government Departments.
