

**MINUTES OF THE MEETING HELD ON 10TH FEBRUARY, 2017 WITH
THE REPRESENTATIVES ALL INDIA CENTRAL EXCISE AND SERVICE
TAX MINISTERIAL OFFRICERS ASSOCIATION**

A meeting was held in the chamber of JS(Admn.-EC) with the representatives of All India Central Excise and Service Tax, Ministerial Officers Association. The following were present:-

2. During the discussion, status on the issues submitted by the Association was informed to the Association. It was decided that issues which are of immediate concern to the Association can be discussed.

3. Issues discussed in the meeting:

- (i) One Time Relaxation in the existing RRs for promotion as Executive Assistant and Inspector.

It was decided that proposal for one time relaxation will be examined.

Action: Ad IIIA

- (ii) Limited Department Compleitive (LDC) Examination for promotion to the post of Superintendent.

It was agreed that this issue will be examined and necessary action shall be taken.

Action: Ad II A&B

- (iii) Discontinuation of interview for posts in promotional posts as per RRs.

Instructions have already been issued for discontinuation of interview for recruitment to all Group 'B' and 'C' posts. However, in certain posts where RRs provide for interview, fresh instructions will be issued for uniformity.

Action: Ad IIIB

- (iv) To finalise RRs for the post of A.O.

It was decided that Ad.IIIB shall provide a copy of the RRs for the posts of DEO and Assistant Programmer and its duties, which are required for finalisation of RRs for the posts of A.O.

Action: Ad IIIB, Ad II A&B

- (v) Effective date of merger of Sepoy and Havaldar- Ad.IV.

It was informed that as advised by DOPT, the effective date of merger of Sepoy and Havaldar shall be 29.08.2008. Necessary clarification is being issued.

Action: Ad IV

- (vi) Clarification to all CCAs for promotion to the grade of Inspector, STA during the vacancies year- Ad.IIIA.

It was informed that necessary clarifications have already been issued with the approval of Chairman, EC, vide Ad.IIIA letter dated 02.08.2016.

Action: Ad IIIA

- (vii) Finalisation of Seniority of AOs.

It was informed that this was processed by DGHRD. Information regarding function/job description of certain posts is required, for further necessary action for finalisation of seniority list of A.O.

Action: Ad IIA&B
