**Office Order 01/2016**

The Judgment/ Order dated 09.02.2012 of Hon'ble CAT, Ernakulum in O.A. No. 688/2004 filed by Smt. Meera Sen was upheld by Hon'ble High Court of Kerala vide their Order dated 16.08.2012 in Writ Petition No. OP (CAT) No. 2693 of 2012 and by Hon'ble Supreme Court in their Order dated 08.07.2013 in SLP (Civil) CC No. 11613-11614/2013 read with the Order dated 19.06.2013 of CAT Ernakulum in Contempt Petition No. 36/2013. Consequently, the Board has provisionally promoted six Senior Hindi Translator (including Smt. Meera Sen) to the post of Assistant Director (Official Language) in field formations under Central Board of Excise & Customs vide Board's Order 01/2014 dated 12.02.2014 subject to the outcome of the Review Application filed by the Department in Hon'ble Supreme Court against their Order dated 08.07.2013 .

2. The above Review Application has been dismissed by Hon'ble Supreme Court vide their Order dated 25.03.2014. Thus, the Order dated 09.02.2012 of the Hon'ble CAT, Ernakulum has attained finality.

3. The matter has been examined in consultation with DoPT and Department of Legal Affairs. It has been decided to make Board's Order 01/2014 dated 12.02.2014 final in respect of the six officers promoted to the post of Assistant Director (Official Language).

In pursuance of the Judgment/Order dated 09.02.2012 of CAT, Ernakulam in OA No.688/2004 filed by Smt Meera Sen, as upheld by High Court of Kerala vide their order dated 16.08.2012 in Writ Petition No. OP (CAT) No.2693 of 2012 and by the Apex Court in their order dated 08.07.2013 in SLP (Civil) CC No 11613-11614/2013 read with the order dated 19.06.2013 of CAT Ernakulam in Contempt Petition No.36/2013, the Department has revised the list of Junior Hindi Translators and Senior Hindi Translators in order of their initial date of joining in different field offices under Central Board of Excise & Customs.
