
Sir,

2. It is, therefore, requested that the requisite information may be furnished to this office by **23.02.2017** positively.



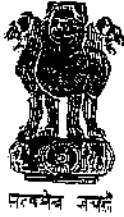
