Sub: Continuation of Posts on Cost Recovery Basis in respect of Customs facilities- reg.

Since 2014, DGHRD has communicated the sanction of posts created on Cost Recovery Basis for customs facilities at ICDs/CFSS/Seaports/Air Cargo Complexes/Courier Terminals etc. (list attached as Annexure-'A').

2. In this connection, it is stated that continuation of such posts on Cost Recovery Basis are to be sought on yearly basis by the field formation. However, it is seen that the proposals are received belatedly much after expiry of validity of posts.

3. It is, therefore, requested to send proposals for continuation of Posts on Cost Recovery Basis in the prescribed checklist-II (Copy Enclosed) along with following information in respect of different facilities falling under your charge:-

- a) Total staff deployed against total posts sanctioned on cost recovery basis in each facility with date of actual deployment (designation-wise).
- b) A Break-up of cost recovery charges payable vis-à-vis actually paid uptil date by each custodian of the facility may be sent to DGHRD along with supporting documents.
- c) Action taken in case of default in payment of cost recovery charges.

4. It may be ensured while sending proposals that no Cost Recovery charges are in dispute or pending payment in respect of Customs facilities.

The above may kindly be sent to this Directorate at the earliest to enable DGHRD to process the proposals further.
