



Dear Secretary,

You may be aware that as a step towards e-governance, physical printing of Gazette Notifications of Government of India has been dispensed with and exclusive e-publishing has been started with effect from 1st October, 2015.

2. For the exclusive e-publishing, the existing e-gazette website i.e. www.egazette.nic.in has been re-designed and upgraded with the provision of direct submission of the matter for publication by the indenting Department/Ministry to the Govt. of India Presses on the web portal.

3. The indenting Departments/Ministries were, therefore, requested to register on the above website and nominate a Nodal Officer having Digital Signature Certificate (DSC) w.e.f. 01.02.2016. In this connection, this Ministry's OM of even number dated 20.01.2016 may also be referred to (Copy enclosed). Most of the Departments / Ministries are however, yet to get registered on the portal.

4. I would, therefore, request you to kindly issue instructions to Nodal Officers concerned in your Ministry/Department, Attached and Subordinate Offices, to get registered on the above portal by 31.05.2016. Gazette notifications will be undertaken w.e.f. 1.6.16 based on electronic submission of Gazette content only, and signed digitally by the nodal officers.
