Subject: Preparation of panel for appointment of **Senior Intelligence Officers** and **Intelligence Officers** on loan / deputation basis in DGGSTI Zonal Unit at Meerut and its Regional Units at Dehradun and Ghaziabad - Reg.

Consequent upon the GST implementation, the Regional Unit of DGGSTI at Meerut had been upgraded to Zonal Unit with two Regional Units at Dehradun and Ghaziabad under its administrative control. The DGGSTI Meerut Zonal unit is in the process of drawing a panel of willing and suitable officers to fill up the vacancies in the grade of Senior Intelligence Officer and Intelligence Officer.

2. The vacancies are to be filled in the grade of **Senior Intelligence Officer** and **Intelligence Officer** at Meerut Zonal Unit, Dehradun Regional Unit and Ghaziabad Regional Unit.

3. It is proposed to fill up the vacant posts of Sr. Intelligence Officers and Intelligence Officers by appointing willing and suitable officers on loan/ deputation basis for a period of 02 / 05 years, as the case may be, from the grade of Superintendent & Inspector. The officers, who have been granted financial up-gradation under MACP Scheme are also eligible to apply.

4. It may be mentioned here that the option for appointment on loan/deputation basis to DGGSTI, once exercised, can't be withdrawn under any circumstances.

5. It is requested that the circular may please be brought to the notice of all the formations under your jurisdiction and the applications of the willing officers be forwarded to this Zonal Unit. The details of willing officers along with the requisite documents as mentioned below may be sent to this office:-

- (i) Complete Bio Data of the Officer.
- (ii) History of postings.
- (iii) List of major cases booked along with amount.
- (iv) APAR Gradings for the last 05 years.
- (v) Vigilance Clearance.
