

The office of Controller General of Accounts, Ministry of Finance, Department of Expenditure as part of its vision to strengthen governance through excellence in Public Financial Management is administering an effective and responsive system for payment, budgeting and accounting in Central Civil Ministries/Departments of Government of India. Besides, Internal Audit and Pension payments are the other key responsibilities of the Department.

The mandate of the office of Controller General of Accounts is implemented through its field offices located in different Civil Ministries/Departments. At present, a number of vacancies in the grades of Non Functional Selection Grade (NFSG) and Junior Administrative Grade (JAG) have arisen in Delhi. The department has decided to fill these vacancies on deputation basis and recently vide Circular dated 09/01/2018 (copy enclosed) invited applications for filling up of these posts. The period of deputation will be initially for a period of three years extendable up to five years. The standard terms and conditions of the deputation will be regulated in accordance with the DoPT Office Memorandum No.6/8/2009-Estt. (Pay-II) dated 17/06/2010 as amended from time to time.

We believe that officers from other Central Services possess the knowledge and experience that would help them to discharge these responsibilities.

May I, therefore, request you to send a panel of eligible and willing Group A officers along with the required documents specified in the Circular ibid for being considered for the above mentioned posts on deputation basis.

Subject: Inviting applications for filling up of posts at Senior Time Scale (STS)/ Junior Administrative Grade (JAG)/ Selection Grade (Non-Functional) level on deputation basis in Indian Civil Accounts Service (ICAS), O/o Controller General of Accounts-reg.

Applications are invited from eligible and willing officers from Central Government and State Governments to fill up 25 posts at JAG/NFSG level and 15 posts at STS level in Indian Civil Accounts Service on deputation basis at New Delhi.

2. The deputation period is initially for 2 years and extendable up to 3 years subject to willingness of individual and approval of Government. The eligibility criteria is indicated at Annexure-A. Standard terms and conditions of the deputation will be regulated in accordance with the DoPT OM No. 6/8/2009-Est.(Pay.II) dated 17/06/2010, as amended from time to time.

3. Willing and eligible officers, who can be spared by their parent cadre immediately on selection, may send their applications in the enclosed proforma (Annexure-I) along with Cadre / Administrative Clearance, Vigilance Clearance, Integrity Certificate.
