2. The post will be filled up on deputation basis from amongst the officers of similar rank working in the formations of Customs, Central Goods and Services Tax or officers holding analogues posts in the Directorate General / Directorates under the CBEC in the same pay scale.

3. Such officer selected for a posting in the Directorate General of Audit, would normally be appointed for a period of 3 years.

4. It is requested that these vacancies and communication may kindly be circulated among officers in your jurisdiction and the applications of the interested and eligible officers may be forwarded to this office on or before 28.02.2018 with their particulars, viz., Name, Educational Qualification, Date of birth, Present post and the Date from which it is held, Scale of Pay along with ACR grading for the last five years, No Objection Certificate and Vigilance clearance from the concerned Commissionerate / Directorate. It may also be brought to the notice of the willing officers that once selected, they will not be allowed to withdraw their name and will also not be relieved till the expiry of the tenure of three years. It may also be certified that no vigilance / non-vigilance case is pending or being contemplated against any such officer.

5. In case, while working in this Directorate General the work and conduct of the officer is not found to be satisfactory, the officer can be reverted to the parent Commissionerate before the completion of the deputation period.
