Sub: Preparation of panel for appointment of Senior Intelligence Officers / Intelligence Officer in the Directorate of Revenue Intelligence, Hyderabad Zone on Deputation- Reg.

The Directorate of Revenue Intelligence, Hyderabad Zonal Unit is in the process of drawing up a panel of suitable candidate for filling up the existing/anticipated vacancies at Hyderabad in the following grades on deputation basis.

Sl. No.	No. of Anticipated vacancies	
01	Senior Intelligence Officer	01
02	Intelligence Officer	02

2. The vacancies are to be filled up by appointing suitable officers of equivalent grade presently working in Customs and Central Tax

3. The selected officer, appointment on deputation, will be entitled for Deputation Allowance as admissible and the officer has to make their own arrangements for residential accommodation. Normally, the deputation in respect of SIO/IO is for period of five years, which is extendable by another two years subject to willingness of the officer, his/her performance, concurrency of his/her parent Commissionerate and approval of the competent Authority.

4. Further, as per Para IV of Ministry's F.No. A-35017/28/92/ADS.III.B. dated 30.06.1994 officers posted in certain charges / organization / assignments are required to complete the "cooling off" period of not less than two years before posting in Directorate of Revenue Intelligence. However, the concerned Chief Commissioner of Central Tax / Customs has been given the power to relax the "Cooling off" period.

5. It is requested that the Circular may be brought to the notice of all the formations under your jurisdiction and the application of willing officers be forwarded to this office. While forwarding the names of the willing officers, the following information in respect of them may be furnished.

1. Complete Bio-data and willingness letter of the officer along with History of Previous Postings;
 2. APAR/ACR Grading for the last 5 years duly verified and attested by the Additional Joint Commissioner (P&V);
 3. Vigilance Clearance Certificate; and
 4. No objection from the competent authority to relieve the officer in the event of his/her selection.
6. The above information / details may kindly be arranged to be furnished at an early date.
