Subject: Preparation of panel for induction as Intelligence Officer in DRI Ludhiana Zonal Unit on deputation basis- reg.

The Directorate of Revenue Intelligence, Ludhiana Zonal Unit (DRI, LdZU) is in the process of drawing a panel of suitable candidates for filling up the existing Vacancy at DRI, LdZU located at Ludhiana in the grade of Intelligence Officer.

2. It is proposed to fill up the vacancy on deputation basis from amongst the officers with minimum three years of service in equivalent grade in Customs and GST (Govt. of India) / Central Excise.

3. The existing / anticipated vacancy is to be filled in this organization. Normally, the deputation is for a period of five years which is extendable by another two years, subject to the willingness of the officers, his/her performance, and the concurrence of his parent formation. It may be made clear to the willing officers that the option once exercised would be final and in the event of selection, they will not be allowed to withdraw the same.

4. Further as per para IV of Ministry's F.No. A-35017/28/92-AD.III B dated 30.06.2004, officers posted in certain charges/organization/assignments are required to complete the 'Cooling Off' period of not less than two years before posting in this

organization. However, the concerned Chief Commissioner of Customs/Central Excise has been given the power to relax the 'Cooling Off' period.

5. It is requested that the circular may be brought to the notice of all the formations in your jurisdiction and the applications of willing officers forwarded to this office. While forwarding the names of willing officers, the following information may also be sent for evaluation by this Directorate:

(i) Bio-data and willingness of the officer along with history of previous posting.

(ii) No objection Certificate from Chief Commissioner to relieve in the event of his selection.

(iii) ACR grading for the last 5 years including for the year 2016-17 duly verified and attested.

(iv) Vigilance Clearance Certificate.

(v) Chief Commissioner's concurrence and permission to relax the 'Cooling Off' period, wherever necessary.
