Sub:- Preparation of panel for appointment of Senior Intelligence Officers & Intelligence Officers on **loan basis** in the Directorate General of GST Intelligence, Patna Zonal Unit and Jamshedpur Regional Unit – Reg.

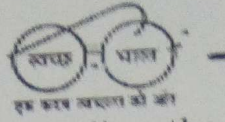
Directorate General of GST Intelligence, Patna Zonal Unit is in the process of drawing a panel of willing and suitable officers for filling up the vacancies in the grade of **Senior Intelligence Officers** and **Intelligence Officers** on **loan basis** for the **Patna Zonal Unit** and **Jamshedpur Regional Unit**.

2. It is proposed to fill up these vacancies by appointing suitable officers from the grades of Superintendents of Central Tax & Customs and Inspectors of Central Tax & Customs, respectively, on loan basis.

3. Normally, the posting on loan basis is for a period of two years, which may further be extended for one year, subject to willingness of the officer, his/her performance, concurrence of his parent Commissionerate and approval of the competent authority.

4. During the period of posting on loan basis, the pay and other allowances of the concerned officer(s) shall be drawn from their respective parent Commissionerate(s).

5. It is requested that the circular may please be brought to the notice of all the formations under your jurisdiction and the applications of willing officers be



forwarded to this office. While forwarding the names of the willing officers, the following information may also be sent for evaluation by this Directorate.

6. (a) Complete bio-data and willingness of the officer alongwith history postings.
- (b) ACR/APAR gradings for the last 5 (five) years (duly verified and attested by the Addl./Joint Commissioner).
- (c) Vigilance Clearance.
- (d) 'No Objection' from the Cadre Controlling Authority to relieve the officer in the event of his selection.

7. The above information/details may please be arranged to be furnished to this Directorate General **by 19.01.2018**.
