**Subject:-Weekly Report in respect of important developments in CBEC for the week –25.01.16 to 29.01.16 reg.**

Based on the inputs received from various sections, following is the compilation of the important developments for the week –25.01.16 to 29.01.16.

**1. Administrative Changes:-**

- Order regarding placement of services of Shri Ashok Kumar Mehta, IRS at the disposal of President's Secretariat on his selection for appointment to the post of Private Secretary to the Hon'ble President of India has been issued vide Office Order No. 06/2016 dated 25.01.2016.

**2. Legislative Changes:-**

- Notification No. 01/2016-Cus(ADD), dated 28.01.2016 has been issued to levy definitive anti-dumping duty on Mulberry Raw Silk (not thrown) of grade 3A and below, originating in, or exported from the People's Republic of China, for a period of five years.
- Notification No. 02/2016-Cus(ADD), dated 28.01.2016 has been issued to levy definitive anti-dumping duty on Melamine, originating in, or exported from the People's Republic of China, for a period of five years.
- Notification No. 03/2016-Cus(ADD), dated 29.01.2016 has been issued to rescind notification No. 10/2010 - Customs dated 19th February, 2010.
- Notification No. 04/2016-Cus(ADD), dated 29.01.2016 has been issued to amend notification No. 133/2008- Customs dated 12.12.2008.
- Notification No. 06/2016-Cus, dated 28.01.2016 has been issued to further amend notification No. 12/2012-Cus dated 17.03.2012.
- Notification No. 04/2016-CE, dated 30.01.2016 has been issued to further amend notification No 12/2012-Central Excise dated 17.03.2012 so as to increase the Basic Excise Duty rates on Petrol and Diesel(both unbranded and branded).

**3. Any circular/Instruction:-**

- Circular No. 02/2016-Cus-IV dated 27.01.2016 has been issued for clearance of livestock and livestock products.

- The Legal Cell has issued instruction dated 22.01.2016 regarding Non-Monitoring of the litigation cases for safeguarding the interests of the Union of India.
