1. Administrative Changes:-

- Order regarding antedating promotion of Shri Ravindra K. Das to the grade of Joint Commissioner of Customs and Central Excise on purely ad-hoc basis, notionally w.e.f. 31.12.2013 has been issued vide Office Order No. 75/2016 dated 28.06.2016.
- Order regarding assigning of additional charge of the post Director General (GST) to Shri Mahender Singh, Director General (Audit) of CBEC has been issued vide Office Order No. 76/2016 dated 01.07.2016.
