**Subject:-Weekly Report in respect of important developments in CBEC for the week –  
30.05.16 to 03.06.16 reg.**

Based on the inputs received from various sections, following is the compilation of the important developments for the week –**30.05.16 to 03.06.16.**

**1. Legislative Changes:-**

- Notification No. 21/2016-Cus (ADD), dated 31.05.2016 has been issued to impose anti-dumping duty on ‘Dichloromethane (Methylene Chloride)’ of all types {tariff item 2903 12 00}, originating in or exported from People’s Republic of China or Russia, for a period of five years (unless revoked, superseded or amended earlier), from the date of imposition of the provisional anti-dumping duty i.e. from the 08<sup>th</sup> of the December, 2015.
- Notification No. 22/2016-Cus(ADD), dated 31.05.2016 has been issued to impose definitive anti-dumping duty on ‘Methyl Acetoacetate’, originating in or exported from USA or China PR, for a period of five years (unless revoked, superseded or amended earlier).
- Notification No. 36/2016-Customs dated 01.06.2016 has been issued to amend various customs Notifications pertaining to EP Schemes to include ICDs Hosur and Nattakkam.
- Notification No. 79/2016-Cus(N.T.) dated 31.05.2016 issued to appoint Common Adjudicating Authority.
- Notification No. 29/2016-CENT, dated 31.05.2016 regarding Indirect Tax dispute Resolution Scheme Rules, 2016.

**2. Any Circular/Instruction:-**

- Circular No. 24/2016 dated 02.06.2016 regarding requirement of Solvency Certificate for the purposes of Private Warehouse Licensing Regulations 2016.
- Instruction vide F.No. B-1/19/2016-TRU, dated 31.05.2016 has been issued to specify that certain amendments made in the Union Budget 2016-17 have come into force from the date when the Finance Bill, 2016 received the assent of the President of India. As a result, these amendments have come into effect from 14.05.2016. These include Notification Nos. 13/2016-ST, 14/2016-ST and certain entries in Notification Nos. 9/2016-ST and 10/2016-ST, all dated 1.3.2016.
