**Subject:-Weekly Report in respect of important developments in CBEC for the week – 05.09.16 to 09.09.16 reg.**

Based on the inputs received from various sections, following is the compilation of the important developments for the week – 05.09.16 to 09.09.16.

**1. Administrative Changes:-**

- Order regarding promotion of Shri M. Srihari Rao, Additional Commissioner to the grade of Commissioner of Customs and Central Excise has been issued vide Office order No. 103/2016 dated 07.09.2016.
- Order regarding promotion of Ms. Suja K.K. to the grade of Joint Commissioner of Customs and Central Excise has been issued vide Office order No. 104/2016 dated 08.09.2016.
- Order regarding assigning of the additional charge of the post of Commissioner Mysore-CX has been issued vide Office order No. 04/2016-DGHRD dated 09.09.2016.
- Order regarding placement of services of Shri S.F.A.I. Ahmed, Assistant Commissioner to the Haj Committee of India for the post Deputy Chief Executive Officer(Operation) has been issued vide Office order No. 105/2016 dated 09.09.2016.

**2. Legislative Changes:-**

- Notification No. 48/2016-Cus, dated 08.09.2016 has been issued to further amend notification No.12/2012-Customs, dated 17.03.2012.
- Notification No. 49/2016-Cus(ADD), dated 07.09.2016 has been issued to extend the levy of anti-dumping duty on imports of Para Nitroaniline, originating in, or exported from People's Republic of China, (imposed vide Notification No. 88/2011-Customs, dated 9th September, 2011) for a period of one year i.e. upto and inclusive of the 8th September, 2017.
- Notification No. 34/2016-CE, dated 08.09.2016 has been issued to further amend notification No.12/2012-Central Excise dated 17.03.2012.
- Notification No. 40/2016-Service Tax, dated 06.09.2016 has been issued to amend Notification No. 25/2012- Service Tax, dated 20.06.2012, so as to make necessary amendment by substituting the clause (a) of entry 5 in opening paragraph.
- Notification No. 02/2016-Cus(SG), dated 05.08.2016 has been issued to amend Notification No. 1/2016-Customs(SG) dated 29.03.2016 to prescribe import prices on CIF basis at or above which safeguard duty on subject goods will not be applicable.
