Based on the inputs received from various sections, following is the compilation of the important developments for the week –**06.06.16 to 10.06.16.**

1. Administrative Changes:-

- Order regarding placement of services of Ms. Ranjana Jha, IRS(C&CE) at the disposal of Department of Revenue for the post of Joint Secretary(Review) has been issued vide Office Order No. 64/2016 dated 06.06.2016.
- Order regarding appointment of Shri Ravindra K. Das, Joint Commissioner of Customs and Central Excise as OSD(CX-I) in Central Excise Wing of CBEC has been issued vide Office Order No. 65/2016 dated 08.06.2016.
- Order regarding assigning of additional charge of the post of Additional Director General of Directorate General of Systems and Data Management, Mumbai to Shri Bani Bhattacharya, Principal Commissioner of Customs(General) Mumbai has been issued vide Office Order No. 66/2016 dated 09.06.2016.
- Order regarding assigning of additional charge of the post of Chief Commissioner of Central Excise and Service Tax, Chandigarh to Shri K.J. Chaudhary, Principal Commissioner of Central Excise, Ludhiana has been issued vide Office Order No. 67/2016 dated 09.06.2016.

2. Legislative Changes:-

- Notification No. 23/2016-Cus(ADD), dated 06.06.2016 has been issued to impose definitive anti-dumping duty on Polytetrafluoroethylene (PTFE)[Tariff Item 3904 61 00], originating in or exported from Russia, for a period of five years (unless revoked, superseded or amended earlier).
- Notification No. 24/2016-Cus(ADD), dated 07.06.2016 has been issued to finalize provisional assessments of all imports of Vitrified/Porcelain tiles, originating in or exported from China PR which have been subjected to provisional assessment pursuant to the notification No. 35/2012-Customs (ADD), dated the 10th July, 2012.
- Notification No. 25/2016-Cus(ADD), dated 07.06.2016 has been issued to rescind notification No. 35/2012-Customs (ADD), dated the 10th July, 2012, which sought to levy provisional antidumping duty on Vitrified/Porcelain tiles, originating in or exported from China PR.
- Notification No. 81/2016-Cus(N.T.) dated 06.06.2016 issued to appoint Common Adjudicating Authority cases investigation by DRI.
- Notification No. 82/2016-Cus(N.T.) dated 07.06.2016 issued to appoint Common Adjudicating Authority cases investigation by DRI.
- Notification No. 83/2016-Cus(N.T.) dated 09.06.2016 issued to appointment of Chandigarh Airport for unloading of imported Goods & Loading of export goods.
- Notification No. 32/2016-Service Tax, dated 06.06.2016 has been issued to amend notification No. 25/2012 - Service Tax, dated the 20th June, 2012, so as to exempt the legal

services provided by senior advocates to a business entity with a turnover up to rupees ten lakh in the preceding financial year.

- Notification No. 33/2016-Service Tax, dated 06.06.2016 has been issued to amend Service Tax Rules, 1994 so as to specify the business entity as the person liable to service tax in respect of services provided by senior advocates.
- Notification No. 34/2016-Service Tax, dated 06.06.2016 has been issued to amend notification No. 30/2012-Service Tax dated 20th June, 2012, so as to prescribe extent of payment of service tax by a business entity as a recipient of services provided by senior advocates.

- The Legal Cell has issued order dated 19.05.2016 regarding empanelment of Sr./Jr. Standing Counsels of CBEC to handle litigation of Indirect Taxes before various High Courts and other fora.
