**Subject:-Weekly Report in respect of important developments in CBEC for the week  
–07.03.2016 to 11.03.2016-reg.**

Based on the inputs received from various sections, following is the compilation of the important developments for the week – **07.03.2016 to 11.03.2016**

**1. Administrative Changes:-**

- Order regarding promotion of 9 IRS(C&CE) officers to the grade of Principal Commissioner of Customs and Central Excise on regular basis w.e.f. 11.04.2015 has been issued vide Office Order No.21/2016 dated 11.03.2016.
- Order regarding promotion of ShriB.Kumar to the grade of Deputy Commissioner of Customs and Central Excise on ad-hoc basis notionally w.e.f. 10.12.2006 has been issued vide Office Order No.22/2016 dated 08.03.2016.
- Order regarding placement of services of Shri Vishal Dashrath, IRS(C&CE:2007) and ShriVaibhav Bajaj, IRS (C&CE:2009) at the disposal of the Enforcement Directorate for the post of Deputy Director has been issued vide Office Order No.23/2016 dated 09.03.2016.
- Order regarding appointment of Ms.HimaniBhayana, IRS(C&CE:2006) as OSD in Service Tax Wing of CBEC has been issued vide Office Order No.24/2016 dated 10.03.2016.

**2. Legislative Changes:-**

- Notification No.06/2016-Cus(ADD) dated 08.03.2016 has been issued to levy definitive anti-dumping duty on Phenol, originating in, or exported from the European Union, Singapore and Korea RP, for a period of five years.
- Notification No.07/2016-Cus(ADD) dated 08.03.2016 has been issued to levy definitive anti-dumping duty on Polypropylene, originating in, or exported from Singapore, for a period of five years.
- Notification No.08/2016-Cus(ADD) dated 11.03.2016 has been issued to amend Notification No.27/2014-Customs(ADD) dated 13.06.2014 so as to modify country of export in Sl.No.3,4,5 and 12 of the Table thereof for levy of anti-dumping duty on PVC (Suspension Grade) originating in or exported from Taiwan, China PR, Indonesia, Japan,

Korea RP, Malaysia, Thailand and USA, in pursuance to the modification in the final findings in anti-dumping investigations conducted by Directorate General of Anti-Dumping and Allied Duties.

- Notification No.20/2016-Service Tax dated 08.03.2016 has been issued to make changes in the ST-3 Form on account of SBC.
- 3. Any Circular :-**
- Circular No.1020/8/2016-CX dated 11.03.2016 has been issued regarding valuation of imported Set top boxes under Section 4 of the Central Excise Act, 1944. It has been clarified that where the circumstances are identical, the judgement of Hon'ble Tribunal in case of M/s BhartiTelemedia Ltd [2016(331) E.L.T. 138 (Tri.-Mumbai)], may be followed for assessment of CVD on imported STBs.
  - Circular No.9/2016-Cus(N.T.) dated 11.03.2016 issued to Clarification with regard to classification of Wireless Microphone sets/systems consisting of one or more Wireless microphones and a wireless receiver.
