- Order regarding postings/transfers of 2 IRS(C&CE) officers in the grades of Additional Commissioner of Customs and Central Excise has been issued vide Office Order No. 14/2016 dated 18.02.2016.
- Order regarding postings/transfers of 15 IRS(C&CE) officers in the grades of Assistant Commissioner of Customs and Central Excise has been issued vide Office Order No. 15/2016 dated 18.02.2016.
- Order regarding assigning of additional charge of 2 posts in the grades of Chief Commissioner/Director General of Customs and Central Excise has been issued vide Office Order No. 16/2016 dated 18.02.2016.

- Notification No. 27/2016-Cus(N.T.) dated 18.02.2016 has been issued for amendment in principal Notification No. 12/97-Cus(N.T.) dated 02.04.1997 inserting Village Jattipur near Samalkha, Panipat(ICD).
- Notification No. 04/2016-ST dated 15.02.2016 regarding Service Tax & Central Excise (Furnishing of Annual Information Return) Rules, 2016.
- Notification No. 05/2016-ST dated 17.02.2016 has been issued to amend Notification No. 22/2015 Service Tax dated 06.11.2015.

- Notification No. 06/2016-ST dated 18.02.2016 has been issued to appoint 01.04.2016 as the date with effect from which, the provisions of Section 109(1) as contained in the Finance Act, 2015 shall come into effect.
- Notification No. 07/2016-ST dated 18.02.2016 has been issued to amend Notification No. 25/2012 by inserting new entry for granting exemption from Service Tax for the services provided by Government or a local authority to a business entity having turnover upto rupees of ten lakh in the preceding financial year with effect from 01.04.2016.
