1. Administrative Changes:-

- Order regarding of Ms. Anamika Singh, Assistant Commissioner of Customs and Central Excise to Delhi Central Excise Zone has been issued vide Office Order No. 41/2016 dated 13.04.2016.
- Orders for assigning of additional charge of the post of Chief Commissioner of Vadodara Zone to Chief Commissioner of central Excise, Ahmedabad has been issued vide Office Order No. 42/2016 dated 13.04.2016.
