**Subject:-Weekly Report in respect of important developments in CBEC for the week –  
14.03.16 to 18.03.16 reg.**

Based on the inputs received from various sections, following is the compilation of the important developments for the week –**14.03.16 to 18.03.16**.

**1. Legislative Changes:-**

- Notification No. 09/2016-Cus(ADD), dated 15.03.2016 has been issued to levy definitive anti-dumping duty on imports of all kinds of plastic processing machines or injection moulding machines, also known as injection presses, having clamping force equal to or more than 40 tonnes, and equal to or less than 3200 tonnes, used for processing or moulding of plastic materials originating in, or exported from Chinese Taipei, Philippines, Malaysia or Vietnam for a period of five years.
- Notification No. 39/2016-Cus(NT), dated 15.03.2016 has been issued to amend Notification No. 32/2016-Cus (N.T.) dated 01.03.2016 [Customs (Import of Goods at Concessional Rate of Duty for Manufacture of Excisable Goods) Rules, 2016] so as to notify 16.03.2016 as the date from which the said rules will be effective. Further the requirement of submission of security for availing the benefit under the said notification is being done away with.
- Notification No. 40/2016-Cus(N.T.) dated 16.03.2016 issued to setting up of a Rail linked at Kashipur Distt. U.S. Nagar, Utrakhand by M/s Kashipur Infrastructure & Freight Terminals Pvt. Limited, Kashipur.
- Notification No. 22/2016-CENT, dated 15.03.2016 has been issued to amend Notification No. 20/2016-Central Excise (N.T.) dated 01.03.2016 [Central Excise (Removal of Goods at Concessional Rate of Duty for Manufacture of Excisable and Other Goods) Rules, 2016] so as to notify 16.03.2016 as the date from which the said rules will be effective. Further the requirement of submission of security for availing the benefit under the said notification is being done away with.
