**Subject:-Weekly Report in respect of important developments in CBEC for the week –
20.06.16 to 24.06.16 reg.**

Based on the inputs received from various sections, following is the compilation of the important developments for the week –**20.06.16 to 24.06.16.**

1. Administrative Changes:-

- Order regarding appointment of Chief Commissioner of Customs, Mumbai Zone-I as Reviewing Authority to review the orders passed by Shri Rajiv Tandon, Principal Commissioner of Customs(General) Nhava Sheva in his capacity as Disciplinary Authority has been issued vide Office Order No. 72/2016 dated 21.06.2016.
- Order regarding antedating promotion of Shri K.V. Ganesh Prasad to the grade of Assistant Commissioner of Customs and Central Excise on purely ad-hoc basis w.e.f. 10.12.2012 has been issued vide Office Order No. 73/2016 dated 22.06.2016.
- Order regarding posting/transfer of 8 IRS(C&CE) officers in the grades of Additional/Joint Commissioner of Customs and Central Excise has been issued vide Office Order No. 74/2016 dated 23.06.2016.

2. Legislative Changes:-

- Notification No. 27/2016-Cus(ADD), dated 23.06.2016 has been issued to impose definitive anti-dumping duty on "Poly Vinyl Chloride (PVC) Paste Resin" originating in or exported from Korea RP, Taiwan, China PR, Malaysia, Thailand and European Union for a period of five years.
- Notification No. 39/2016-Cus, dated 21.06.2016 has been issued to further amend Notification No. 96/2008-Customs dated 13.08.2008 so as to include 'Republic of Togo' and 'Republic of Chad' in the list of countries eligible for preferential tariff under the said notification.
- Notification No. 40/2016-Cus, dated 21.06.2016 has been issued to further amend notification No. 53/2011-Customs dated 01st July, 2011 so as to provide deeper tariff concessions in respect of specified goods imported from Malaysia under the India-Malaysia Comprehensive Economic Cooperation Agreement (IMCECA) w.e.f. 30.06.2016.
- Notification No. 35/2016-ST, dated 23.06.2016 has been issued to exempt taxable services from the whole of Krishi Kalyan Cess leviable thereon with respect to which the invoice for the service has been issued on or before 31st May, 2016 subject to the condition that the provision of the service has been completed on or before 31st May, 2016.
- Notification No. 36/2016-ST dated 23.06.2016 has been issued to exempt service tax on taxable services by way of transportation of goods by a vessel from outside India upto customs station in India with respect to which the invoice for the service has been issued on or before 31st May, 2016 subject to the condition of production of customs certified copy of the import manifest or import report required to be delivered under section 30 of the Customs Act, 1962.

- Notification No. 90/2016-Cus(NT) dated 24.06.2016 has been issued to amend Notification No. 110/2015-Cus(NT).

3. Any Circular/Order:-

- The Legal Cell has issued order dated 18.06.2016 & 22.06.2016 vide which the order of 111 Sr. / Jr. Standing Counsel who were on the panel of CBEC as on 14.10.2014 and who were further empanelled for a period of three vide order dated 09.06.2016 were rescinded. Board vide letter dated 24.06.2016 has directed the field formations to initiate action for drawing a fresh panel keeping in view the requirement of a particular zone the existing slots which have previous been fallen vacant.
- Circular No. 30/2016-Cus dated 24.06.2016 has been issued to explain the changes made vide Notification No. 90/2016-Cus(NT)
