**Subject:-Weekly Report in respect of important developments in CBEC for the week –  
21.11.16 to 25.11.16 reg.**

Based on the inputs received from various sections, following is the compilation of the important developments for the week –21.11.16 to 25.11.16.

**1. Administrative Changes:-**

- Order regarding appointment of 03 IRS Officers in the Government of Bihar on deputation basis for a period of 03 years vide Office Order No. 139/2016 dated 25.11.2016.

**2. Legislative Changes:-**

- Notification No. 139/2016-Customs(N.T.) dated 25.11.2016 issued for permission to setup of an ICD at Jharsuguda, Odisha.
- Notification No. 140/2016-Customs(N.T.) dated 25.11.2016 issued for rescinds publication of daily list of import and export rules, 2004-Notification No. 128/2004-Cus(N.T.) dated 19.11.2004.
- Notification No. 03/2016-Cus(SG), dated 23.11.2016 has been issued to levy safeguard duty on Hot Rolled flat sheets and plates (excluding hot rolled flat products in coil form) of alloy or non-alloy steel having nominal thickness less than or equal to 150mm and nominal width of greater than or equal to 600mm.
- Notification No. 53/2016-Cus(ADD), dated 25.11.2016 has been issued to levy anti-dumping duty on the imports of Low Ash Metallurgical Coke originating in or exported from Australia and People's Republic of China for a period of five years.
- Notification No. 50/2016-ST, dated 22.11.2016 has been issued to amend notification No. 20/2014-ST dated 16th September, 2014 so as to provide exclusive jurisdiction to LTU-Bangalore with respect to online information and database access or retrieval services provided or agreed to be provided by a person located in non-taxable territory and received by a 'non-assesse online recipient'.
