1. Administrative Changes:-

- Order regarding of placement of services of Shri Rajeev Agarwal, IRS and Shri Bashishta Prasad, IRS on deputation basis at the disposal of Goods and Service Tax Network – Special Purpose Vehicle for the posts of Senior Vice President has been issued vide Office Order No. 98/2016 dated 24.08.2016.
- Order regarding promotion of Shri A. Vijay Anand, IRS officer to the grade of Principal Chief Commissioner of Customs and Central Excise has been issued vide Office Order No. 99/2016 dated 26.08.2016.
- Order regarding promotion of 11 IRS officers to the grade of Chief Commissioner / Director General of Customs and Central Excise has been issued vide Office order No. 100/2016 dated 26.08.2016.

- Notification No. 32/2016-CE, dated 26.08.2016 has been issued to further amend Notification No.12/2012-Central Excise dated 17.03.2012 so as to levy Basic Excise Duty at a concessional rate of 2% on Aviation Turbine Fuel drawn by operators or cargo operators from the Regional Connectivity Scheme (RCS) airports for a period of 3 years.
- Notification No. 114/2016-Cus(N.T.) dated 26.08.2016 issued for setting up CFS by M/s Visakha CFS & Legislation Pvt. Ltd. Chennai.
