The posting of officers as per the aforesaid Office Orders has been done keeping in view the fact that GST is being introduced from 1st July, 2017 and hence officers have to be in position well in time to ensure that all appropriate actions are taken for being in readiness for a smooth transition to GST and to guide the trade and industry.

3. The aforesaid Office Orders of the Board have also prescribed time lines, as indicated in the table above, for compliance in respect of each of the orders.

4. Representations have been received from certain officers with regard to their postings as per the Office Orders. In this context, it may be mentioned that the aforesaid Office Orders of the Board very clearly state that no representation would be considered unless the officer joins his new place of posting.



In case the officers are not relieved by the given date, they would be deemed to have been relieved from the date indicated in the aforesaid Office Orders.

6. Compliance report in this regard may kindly be sent to the ADG, HRM-II, which would also facilitate the DGHRD to process the representations of the officers for appropriate consideration by the Board, once the joining reports are received in the Directorate.


